AND WHEREAS BOSSGEN is a CHARITABLE AND SOCIAL DEVELOPMENT TRUST, with a primary moto for developing entrepreneurs and setting up a startup ecosystem and incubation centres in Puducherry;

Now, therefore, in consideration of the premises hereinabove, the parties hereto agree as follows:

CL .1 SCOPE OF THE AGREEMENT

The purpose of this Agreement is to establish a collaborative partnership between BOSSGEN and the College to foster entrepreneurship, innovation, and technological development among the students.

CL.2 MODALITIES OF COLLABORATION

2. Technical guidance on developing startup ideas.
3. Participation and support in national-level competitions, hackathons, and other entrepreneurial events.
4. Training sessions for students on emerging technologies.
5. Mentorship programs to guide students towards becoming successful entrepreneurs.
6. Technical support for students seeking employment in various sectors.
7. Involvement of students as interns for developing software products for startup companies and other firms across India.
8. Monitoring the progress and utility of student internships.
9. Assistance in generating funds for startups originating from the College.
10. Personality development classes and soft skills training for students from the first year to the final year.
11. Bringing mentors and impactful persons for awareness programs scheduled by IIC (Institution's Innovation Council).
12. Providing trusted resources to conduct workshops, ideathons, hackathons, and other entrepreneurial activities.

CL.3 RESPONSIBILITIES OF IIC-TGASC.

1. The IIC-TGASC will provide space for stacking of materials for the conduct of programs.
2. The IIC-TGASC will provide parking access to the vehicles inside the campus during working hours for BOSSGEN members.
3. The authorised nominee will be inducted as Member of IIC-TGASC, and its sub-committees as per the provisions given in the guidelines.
4. The IIC-TGASC shall provide all other infrastructure necessary for running of the Institution's Innovation Council projects successfully.

CL.4. DURATION OF THE PROJECT.

The PROJECT duration will be initially for two years from the date of its signing this agreement by the concerned parties and need for its extension, if any will be reviewed by mutual agreement between the parties.

CL 5. COMPLETION.

The PROJECT envisaged shall be deemed to have been successfully completed, as assessed by Monitoring Committee. In case, during the tenure of the PROJECT it is found that the PROJECT is not likely to lead to successful completion, all the parties hereto can jointly decide to abandon the PROJECT prematurely. In case of premature abandonment of the project, the unutilised project money and assets created from the project money should be returned to the party.


CL. 6 RESULTS OF THE PROJECT.

CL.6.1 It is the responsibility of BOSSGEN to protect any intellectual property rights (IPRs) that may result from the PROJECT and utilize the IPR or license these to other parties as per mutually agreed terms and conditions. The IIC-TGASC shall monitor a fair and equitable sharing and utilisation of IPRs.


CL. 6.2 The intellectual property generated in the PROJECT shall be owned as per the guidelines of Nation Innovations and Startup Policy (NISIP).

CL.7 CONFIDENTIALITY.

During the tenure of the Agreement and during such extended period/s as agreed upon, after five years from the successful commercialisation of the PROJECT, which ever is later, BOSSGEN, and IIC-TGASC undertake on their behalf and on behalf of their employees/representatives/associates to maintain strict confidentiality and prevent disclosure thereof, of all or any part of the

CL.8 EFFECTIVE DATE, DURATION, TERMINATION OF THE AGREEMENT.

CL. 8.1 The Agreement shall be effective from the date of signing and shall remain in force for a period of two years from the said date.


CL. 8.2 During the tenure of the Agreement, parties hereto can terminate the Agreement either for breach of any of the terms and conditions of this Agreement or otherwise by giving **three months'** notice in writing to the defaulting party. Failure of either party to terminate the Agreement on account of breach or default by the other shall not constitute a waiver of that party's right to terminate this Agreement.

CL. 9 FORCE MAJEURE.

Neither party shall be held responsible for non-fulfilment of their respective obligations under this Agreement due to the exigency of one or more of the force majeure events such as but not limited to acts of God, War, Flood, Earthquakes, Strikes not confined to the premises of the party, Lockouts beyond the control of the party claiming force majeure, Epidemics, Riots, Civil Commotions and/or provided on the occurrence and cessation of any such event the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cessation. If the force majeure conditions continue beyond six months, the parties shall jointly decide about the future course of action.




